By using our web page, you consent to our Privacy policy.

1. What information do we collect and why?

We do not collect any personally identifiable information except when you submit it voluntarily through forms. The information collected will be used for the purposes specified for when it was collected, to respond to your inquiries, and fulfil e-mail messaging programs to notify visitors about new content or services on our website. The information is also used to individualize your holidays in Croatia by matching your personal needs and requirements.

In particular, during on-line inquiry and booking process you will be asked to enter contact information such as your name, e-mail address, mailing address or contact number.

Any information you give us will be stored and managed carefully, and will not be used in ways to which you have not consented. We will not sell, rent, or exchange such personally identifiable information to any other organization or entity.

2. Collecting information

When you visit our website our web server automatically collects information about IP address of your computer, type of your browser, time of your access, referring web address and all the information about the pages you have visited on our site. That data is used for running our statistics about the use of pages, so that we could improve user experience.

3. Google Analytics

This website can use Google Analytics to analyse the use of this website. Google Analytics uses cookies, to collect standard Internet log information and visitor behaviour information in an anonymous form. The information generated by the cookie about your use of the website (including IP address) is transmitted to Google. This information is then used to evaluate visitors' use of the website and to compile statistical reports on website activity.
